
Spencer Frye



Spencer Frye is a small business owner, a construction manager, a non-profit executive, and a member of the Georgia House of Representatives. He has taught English in Haiti, helped to export American ambulances overseas, and co-founded Envirotech, a company that began by recapturing recyclable oil and which now operates globally. In 1999, Spencer felt called to begin working with Habitat for Humanity, to serve his home town by helping to provide more opportunities for his neighbors to work for a better standard of living, while improving the quality of life for everyone. After managing the construction program with Habitat for 7 years, Spencer assumed the responsibilities of executive director. Under his leadership, the Re-Store has doubled its sales, while Habitat has expanded its services to include installing handicap ramps, offering emergency home repair, and providing low-impact whole house recycling. Spencer also founded a program which uses the successful Habitat model to renovate neglected duplexes and

apartments for working families. In addition, he is a co-founder of Create Athens, a professional group working to make the arts even more enriching for the city and the region. As a business owner and as executive director, Spencer Frye has met and worked with stakeholders from all over the community and successfully balanced the interests of citizens, private enterprise, and government.

Ted Pestorius



Ted Pestorius has been with CDC since 1990, and has served as the Management Officer of NCEZID and its precursors since December 2006. Prior to that Pestorius was the Deputy Director for Management and Operations for CDC's Division of Viral and Rickettsial Diseases (DVRD). He has also been the Acting Associate Director for Management and Operations at CDC's National Center for HIV, STD, and TB Prevention (NCHSTP); Chief, Financial and Administrative Services Office at NCHSTP; Deputy Chief, Prevention Support Office at NCHSTP/OD; Project Officer for the Program Development and Support Branch (PDSB), Division of STD Prevention/NCHSTP; and Project Officer, Community Assistance, Planning, and National Partners Branch (CAPNPB), Division of HIV Prevention/NCHSTP.

Early in his public health career, Pestorius served as the Director of the Connecticut STD Control Program and as Supervisor, Riverside STD Clinic in Houston, Texas. Prior to that he was a Disease Intervention Specialist in Maryland and Illinois where he educated persons infected with syphilis and HIV about their disease and performed partner notification and referral services.

Joan Prittie



Joan Prittie is the Executive Director of Project Safe, an Athens, Georgia based non-profit organization that is working to end domestic violence through crisis intervention, ongoing supportive services, systems change advocacy and prevention and educational programs.

Joan is a graduate of Bradley University and the University of Georgia School of Law, an Athens resident for 24 years, and describes herself as a "recovering attorney." As a lawyer with the Prisoner Legal Counseling Project, Joan represented indigent inmates in the Georgia state prison system. During that time, she helped develop that Battered Women's Clemency Project, and worked on behalf of 78 women in prison for killing their abusers, securing one sentence

commutation and a dozen paroles.

Joan was the recipient of the 2014 ATHENA award for professional excellence, community service and leadership development. In 2010, she was one of just 15 people nationwide to win the Sunshine Peace award for developing resources and facilitating social change to end violence against women and children, and in 2008 she won the Shining Star award for innovation in domestic violence work. She's the former chair of the Georgia Coalition Against Domestic Violence, and is the current principal author and editor of the Georgia Domestic Violence Bench Book—a resource book for judges.

A board member of the Athens Nurses' Clinic and high school Sunday school teacher at Covenant Presbyterian Church, Joan also teaches classes in fundraising and grant proposal writing at the Non Profit Institute at UGA.

Tracie Sanchez



A classic late bloomer, but a well-rounded one; Tracie Sanchez completed her BA at UGA in 1988 and moved to DC to intern for her Senator, a move that tested her public servant desires and thus led her to a 2 decade career in the private sector as a graphic designer for McKinsey & Co. in DC and SF. Returning to Georgia in 2003 she joined the newly formed Institute for Leadership Advancement at UGA as a Coordinator of Leadership and Service Efforts. Experiencing the values based leadership development curriculum reawakened her desire to serve the public and she completed an MPA in 2011. Devotion and practice of alternative transportation solutions had always been her passion and she focused her public policy course work in that arena and now works on multiple efforts. She founded the Georgia Trail Summit and in October 2016, joined the Southeastern Trust for Parks and Land as Director of Community Relations & Outreach.

David Tanner



Mr. David Tanner is the Associate Director of Governmental Services and Research at the UGA Carl Vinson Institute of Government. Mr. Tanner manages the division's faculty and staff and coordinates a wide range of customized technical assistance and research projects conducted for state and local governments. The work of the division includes demographic and economic analysis, survey research, human resource assistance, personnel testing, environmental impact analysis, planning, and project support. Prior to joining the Institute, Mr. Tanner served as the deputy director at the Georgia Governor's Office of Planning and Budget (OPB), where he helped the State address key budget and policy issues for more than 12 years.
