- Attempting to attend all Board meetings, conference calls, and events (note that past meetings and events have occurred in Atlanta, Athens, and Washington, D.C.) and shall miss no more than one official quarterly Board meeting (note that any Member absent from two (2) meetings in any fiscal year shall be considered to have resigned from the Board);
- Being actively engaged in advancing the purpose of the Board, including, but not limited to, serving as an officer or committee member;
- Recruiting other SPIA alumni to serve on the Board and promoting SPIA among other alumni;
- Providing feedback and suggestions to SPIA’s Dean on ideas for alumni engagement;
- Staying informed about SPIA events and news via SPIA’s social media accounts, SPIA website and other media; and
- Working to advance the mission and goals of the SPIA as presented by SPIA’s Dean.

**REQUIRED INFORMATION** –

1. A completed application form, including a signed acknowledgment that the nominee has read the Board’s Bylaws and agrees to fulfill all requirements identified in the Eligibility section above;
2. A current resume;
3. A personal statement explaining how the nominee has supported SPIA or UGA since graduation and what ideas or abilities the nominee can contribute to the Board to help the Board achieve its goals in the areas of fundraising, planning alumni events, and mentoring current SPIA students.
