Over 700 officials from 60 countries have availed of this training since Fall 2006.

The project seeks to induce export control harmonization among ASEAN states by using CSCAP working group meetings as a forum for discussions on common challenges and opportunities for Asian states to monitor and regulate trade and transshipment of sensitive items and dual-use technologies. This involves CITS team to not merely produce assessments and briefings for DOE on export control issues in specific Asian states but to also interact with the Asian officials and encourage them to share information on their national systems at CSCAP meetings using CITS framework and methodology.

Products are not for public sharing.
