Reissues of Historical Sound Recordings

Rare recordings from the archive of historic sound recordings from the collection of John Anthony Maltese have been used in numerous historic LP and CD reissues by recording companies around the world, including: BMG Classics (U.S.), RCA Red Seal Records (U.S.), Masters of the Bow (Canada), Naxos (England), Strad Records (England), Symposium Records (England), the Maud Powell Foundation (U.S.), and Marston Records (U.S.). In 2003 he helped to discover and release rare cylinder recordings made in Russia in the 1890s, and in 2015 he discovered the only known copy of a recording of the pianist Josef Labor (1842-1924). The Labor recording, released on compact disc in 2018 was described by Gregor Benko, founder of the International Piano Archives at the University of Maryland, as “the rarest piano record known to me, and in my estimation, one of the most important.”
