Class Participation and Reading Questions

Class attendance and active participation are vital to success in this course. Class participation will be graded by attendance and by quality participation in class activities. Each class session involves readings and case studies. Students should take notes on all readings and case studies and be prepared to discuss in class. For the readings, you will have to submit a reading question online to eLearning Commons by 10PM on Wednesdays. For the case studies, be prepared to discuss what you would do in those situations.

Case Presentation

The Stillman book includes cases at the end of each chapter. Students will be assigned to groups to present a case to the class. You should discuss the case's problems and solutions, practical relevance, application to theory, and your own innovative solutions to the management challenges. You must draw on five additional sources. Presentations should be no longer than 20 minutes in length with class discussion following.

Ethical Dilemma Memo

Students will write a 5 page memo on a public sector ethical dilemma of their choosing. Instructions for format and content will be provided. Students will bring a draft memo to class on November $10^{\rm th}$ and work in small groups to refine their memos. Final memos are due by 10PM on November $18^{\rm th}$.

Midterm and Final Exams

There will be a midterm and final exam, which are both open-note, take-home, and essay form. Exams will be posted online, and students must submit the exams online by the assigned time. Grading rubrics will be provided prior to the exams.
