**Exams**: The three exams will combine multiple choice, true/false, and short essay questions. All exams will be administered online on eLC, will be scheduled during our class time, and can be taken at the location of your choice (including our classroom). The exams will test material from your readings, lectures, and discussion sections. The exams will be open note/open book but collaboration among students is prohibited. Unless otherwise noted, exams will NOT be cumulative. Two of your three exam grades will be worth 25% of your final grade each, and your highest exam grade will be worth 30% (as determined automatically at the end of the semester for each individual student). **Makeup exams are only permitted in extraordinary circumstances such as documented medical emergencies**.

**Other Graded Activities:** Over the course of the semester, you will write three essays reflecting on the material presented during discussion time in class (approved discussion reflection topics will be listed on eLC). Each discussion essay is worth 5% of your final grade, for a total of 15%. In addition, there will be a group activity proposing a reform to the Georgia criminal justice system (worth 5% of your final grade). More details on these assignments will be provided on eLC.
