This book-style dissertation on judges and jury instructions in federal criminal trial courts tackles three related empirical questions: (1) how do judges' preferences and professional backgrounds impact their decision-making on jury instructions, (2) what impact do jury instructions have on verdicts, and (3) do a judge's race and sex impact his or her use of implicit bias jury instructions? To answer these questions I will collect and analyze a new dataset of federal district court cases including docket sheets, case filings, jury instructions, judicial biographies, sentencing data, and district-level case reports.

This article surveys pretrial detention's history, costs, and how justice is meted out differently in rural and urban counties, especially in Florida. Using a variety of data sources, I empirically explore Florida's pretrial detention system finding, among other insights, Florida's rural counties detain individuals at a rate 35% higher than their urban counterparts.
