Course Description

This course will use the interstate dispute between Alabama, Florida and Georgia over the shared river basin of the Appalachicola-Flint-Chattahoochee (ACF), popularly known as the "Tri-state Water Wars," as the framework to explore issues around the application of federal and state environmental legislation in the context of shared river basins, the interaction of statutory law and common law in the area of water resources, the interplay of federalism in our constitutional structure as it relates to the application of law and regulation in this context, and the legal and regulatory elements involved in Original Action Case No. 142, Florida v. Georgia - in which Florida sued Georgia in the United States Supreme Court seeking an equitable apportionment of the water resources of the ACF basin. The course will also explore the complexities around the negotiation of interstate compacts over shared water basins in the context of the ACF dispute.

- Will use the records only for personal academic use during the specific course.
- Understand that faculty members have copyright interest in their class lectures and that they agree not to infringe on this right in any way.
- Understand that the faculty member and students in the class have privacy rights and agree not to violate those rights by using recordings for any reason other than their own personal study.
- Will not release, digitally upload, broadcast, transcribe, or otherwise share all or any part of the recordings. They also agree that they will not profit financially and will not allow others to benefit personally or financially from lecture recordings or other course materials.
- Will erase/delete all recordings at the end of the semester.
- Understand that violation of these terms may subject them to discipline under the Student Code of Conduct or subject them to liability under copyright laws.
